Subject - Relief to borrowers engaged in exports under RBI Trade Relief Measures Directions 2025 dated November 14, 2025.

The objective criteria for considering the relief is as follows:

- 1. Bank shall satisfy that the export borrower is impacted/ affected by trade disruptions caused by global headwinds. This shall be mentioned in the application given by the Borrower for availing relief under this scheme.
- 2. The borrower is engaged in exports relating to any of the sectors specified in the Annexure. (Annexure given below).
- **3.** The borrower had an outstanding export credit facility as of **August 31, 2025.**
- 4. The account(s) of the borrower is **'STANDARD'** as on August 31, 2025 with our Bank and also with other banks/Institutions if there are any borrowing. (Basis certification from other banks)
- 5. In case the borrower is having credit facilities with us which are not export credit facilities but enjoying export credit facilities with other Bank, are also eligible under this scheme. Provided, Bank shall satisfy basis a certification from the other Bank who has extended export credit facilities that the above conditions are fulfilled in order to extend relief under this scheme.
